Biological and constitutional factors are not determinants of juvenile delinquency, but become a kind of «favorable background» of personal deformation, which determines the propensity of motivational and behavioral mental formations of a teenager to negative external factors. Due to the interaction of internal constitutional factors and external adverse antisocial influences, in the absence of effective positive educational or preventive effects, negative personal characterological changes occur, which in turn determine the deformation of the motivational and behavioral spheres of a teenager. We argue that the key area that is subject to deformation and, therefore, determines the dissimilarity of delinquent adolescents with a tendency to violence is their social adaptation. In turn, the social isolation of violent juvenile offenders is caused by a combination of external (socio-psychological) and internal (individual psychological) factors, which together determine the extreme deformability of legal awareness.
