**Abstract.** The article describes the results of the study of basic beliefs of the personality of the relationship of world assumptions with the individual's conception of social interaction. It is shown that world assumptions influence, social life of the person, interaction and interpersonal relations. By analyzing the scientific ideas, the importance of studying basic beliefs for psychological support of internal affairs officers is argued. It is defined, that representation of social interaction represents social communications of the person with people and groups. The hypothesis on relations between basic beliefs and representations about social interaction is formulated. The research sample included 168 persons, the average age of the respondents was 24.5 years ( $SD = 2.4$  years), and 42.3 % were men. Statistically significant correlations (at  $p < 0.01$ ) characterizing the relationship of seven basic beliefs with the indicators of social interaction of personality were obtained. The hypothesis of conducted study finds confirmation in groups of correlations. World assumptions about benevolence, fairness, and good fortune are related to an individual's perception of the social support of others. World assumptions about the ability to control life events are related to social self-esteem. It is shown that the prospects for further research are related to the verification of

findings and further study of the influence of world assumptions on social interaction.
